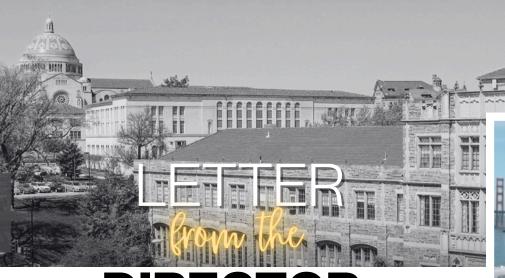

DIRECTOR

The late Art Ciocca, co-founder of The Wine Group, called me to help with a project about two decades ago. He wanted to run a workshop for faculty at a university he'd been supporting philanthropically to show them all that was involved in business above and beyond the pursuit of profit. They were good people, but like a lot of people of faith, possessed of a prejudice that business is inherently dirty business, populated by — let's be candid— "greedy bastards."

Art —who had derived a lot of satisfaction not only from delivering great value for his customers, but also from mentoring hundreds of people he worked with, watching them develop their own talents and virtues— wanted to open minds to all the different kinds of good that a well-built business can accomplish, from economic dynamism to personal growth, and family and community stability. "Andreas, let's see if we can show them what Entrepreneurship is really all about."

So we challenged that faculty to innovate: to come up with business ideas that would solve or improve specific problems or pain points in people's lives. They loved it! Their working groups got genuinely energized by the good they could do by providing a wonderful good or service and they loved working through the processes of ideation and prototyping we led them through.

We thought the experience would create a window of empathy for what's in the hearts and minds of business people, but we found cynicism instead: most people couldn't assume good will in others: "If I started a business, it wouldn't be for selfish reasons – but I don't trust others not to work primarily from greed."

Years later, when Art spent some time in my classroom at the Catholic University of America, he loved interacting with students and was delighted by the openness of leadership and faculty. That's why he committed to helping The Busch School of Business launch and build an entrepreneurship center dedicated to a new and open approach. Without being naive about the possibility for human selfishness, we appeal to the God-made goodness of each person, challenging them to channel their talents and dreams for good, letting business be shaped by Catholic Social Teaching and sound economic principles.

The Ciocca Center for Principled Entrepreneurship is **where innovation meets personal vocation**, and I invite you not only to peruse the pages of this annual report, but also to explore our new website, <u>CioccaCenter.com</u>, to see how we can help you, whether you're a student at any level or in business for yourself.

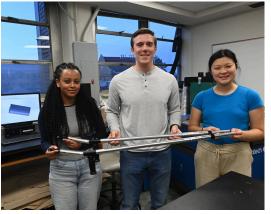

CINSTITUTE INSTITUTE



Cluny Institute is a multidisciplinary organization hosting events, publishing Cluny Journal, offering classes and workshops, and giving grants. It's named for Cluny Abbey, the most important cultural institution of the Middle Ages. The abbey's founding mission was spiritual renewal in the monastic tradition, but it quickly became the nexus of learning, cultural transmission and technological advancement. The Cluny Institute aspires to be the same, at the intersection of Athens (reason), Jerusalem (faith) and Silicon Valley (innovation and building).



- · Cluny Journal has 5k subscribers in its first year; it is publishing award-winning and emerging novelists, academics, philosophers, poets, technologists and more. A particular innovation is the "Trialogue," in which the Journal facilitates a written conversation between three prominent thinkers without their knowing who they are writing with until the end of the conversation.
- · Cluny launched with an ambitious schedule of 8 experimental "encounters" and one conference in its first year. These ranged from a silent event in Manhattan, to a private dinner with philosopher Charles Taylor, to an artfocused salon at The Moore in Miami, and a private book discussion at the NAC with Bishop Barron, Peter Thiel and more.

The VentureLab@CatholicU has developed a dynamic, hands-on curriculum designed to empower both undergraduate and graduate students at The Catholic University of America to explore and launch new ventures. Students from the Busch School of Business and across disciplines—including Architecture, Engineering, and Biotechnology—are guided through the entrepreneurial process using the Business Model Canvas as a foundational framework. Rooted in Catholic Social Teaching, our approach emphasizes ethical innovation, human dignity, and the common good.



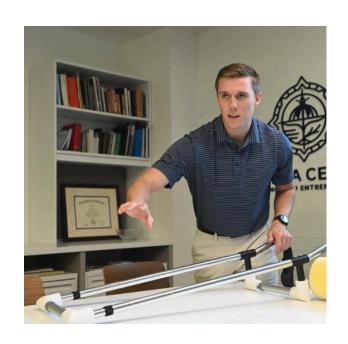
This academic year alone, students created over 30 new ventures, tackling a range of global and local challenges. These include accelerating access to critical pharmaceuticals, launching healthcare concierge services for critically ill patients in Africa, developing AI-powered solutions for TikTok users seeking recipes, designing an adaptive hand grip enabling the elderly and physically limited individuals to play Pickleball, and introducing a health-conscious energy drink.

Through experiential learning and interdisciplinary collaboration, students don't just learn about entrepreneurship—they live it.

Student Businesses in the Spotlight:

Skolios

John Whelan developed a project to bring to market a simple device that helps scoliosis patients. With our help, John was able to collaborate with the engineering department to refine his device and ready it for beta testing. John was one of a select group of students from DMV-area universities invited to pitch his business project at DC Start-Up and Tech Week's University Day.



SCIAN Solutions

Student Nolan Terry created SCIAN Solutions, which he describes as a "tech-enabled service company that creates value by designing and implementing custom CRM systems, sales automations, and revenue workflows tailored to each client's business. The hands-on service model ensures small and mid-sized teams convert more leads, save time, and scale efficiently." VentureLab assisted Nolan by helping him pivot away from a focus solely on the real estate sector. We also allowed him to use VentureLab itself as a test case and feedback from us helped him grow to 10 active clients.



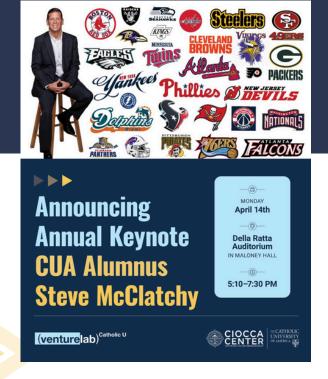
VentureLab Keynote Address

We filled the Della Ratta auditorium with students eager to hear from Steve about hard work, continuous improvement, and being fully engaged in work and at home.



Hoppin'

Alumni Jack Dee and Will Simone pivoted a business they first workshopped with us as students. They describe their project: "With an average retention rate of 77.5% at private universities, millions are lost to student churn rates each year. Hoppin' encourages students to discover and share social activities based on common interests while giving schools a way to promote campus events alongside them." These two alumni launched the beta for their app this spring, amassing more than 700 users on the Catholic U. campus in the course of two weeks. They are now working to refine and build features based on student and university feedback.

Röpke-Wojtyła Fellowship

The Röpke-Wojtyła Fellowship challenges senior level undergraduate students from around the country to a **deeper understanding of the human person** through an examination of the relationship between business in the free enterprise system on the one hand and religion and culture on the other.

An important purpose of the Fellowship is to **build an interdisciplinary community** of thinkers to champion a free and moral society. We tackle questions about the conditions under which the market system contributes to human fulfillment. The Fellowship is named after two intellectual giants who grappled with similar questions in their lives and in whose footsteps we hope to follow: Wilhelm Röpke and Karol Wojtyła (Pope St. John Paul II).



Rounding out our eighth year of existence, our alumni Fellows are pursuing vocations in religious life, academia, medicine, law, business, political and economic policy, education, and the non-profit industry. It is our hope that whichever career path they choose, they come to appreciate the importance of both markets and religion for a well-functioning society, something that is not fully appreciated in today's marketplace for ideas.

We hosted 16 Fellows from 9 different institutions this academic year, chosen from a prestigious and competitive pool.

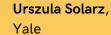

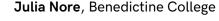

CEDE launched a new program, the Startup Venture Challenge, in 2025 and guided 27 high school students through the process of identifying and launching their own business startup. Participants launched businesses inspired by the True, the Good, and the Beautiful in the course of a 10-week virtual startup bootcamp.

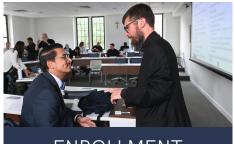
